### **GRANT PARTIES AND PURPOSE**

This Loan Agreement is between the Missouri Department of Conservation (“Department”) and \_\_\_\_\_ (name of school) (“Recipient”). The purpose of the grant is to reimburse bus transportation costs for the Discover Nature Schools Second Grade field experience(s).

### **GRANT PERIOD**

The period of this grant is **July 1, 2025 to May 31, 2026. The grant period begins on the date of the approval letter. Costs incurred prior to the grant period are ineligible for reimbursement.**

### **REQUIREMENTS**

Any travel must be to provide hands-on outdoor learning experiences directly related to *Discover Nature Schools Second Grade Curriculum*. The goal is to give students the opportunity to explore lessons in an outdoor setting.

**Eligible** field experiences:

- Must occur at an outdoor area with natural features.
- Must provide students with opportunities to explore and investigate using student guides and applicable science tools as set forth in the *Field Experience Guidance* section of the Teacher Guide on page 196.
- During the field experience, *DNS Second Grade* lessons should be teacher or chaperone-led. This allows the teacher the opportunity to gain experience in teaching lessons outdoors and connect prior learning from the school yard.
- Examples of acceptable destinations include: MDC Conservation area or MDC Nature Center, state park, city or county park, national forest, fish hatchery, pumpkin patch, apple orchard or other area as agreed upon by their local conservation educator.

### **REIMBURSEMENT**

**Reimbursement is for actual transportation costs only and cannot include admission fees, food, fees for area shelters, or lodging.** Trips must be within 100 miles of school (one way) and within the state of Missouri. More than one trip may be included for reimbursement, however, maximum reimbursement will not exceed a total of \$7 per student per year up to \$3,500.

**Upon the conclusion of school year field experiences and by June 15 of each year, the Discover Nature School agrees to submit the Annual Report and Evaluation** containing the location of the field experience(s) that occurred during the grant period. The Department will provide the Annual Report and Evaluation link via email by April 15. If the Annual Report and Evaluation is not submitted by all participating teacher(s) from the Discover Nature School, then the Department may terminate this Agreement at its discretion.

**LEGAL COMPLIANCE, INDEMNITY SAFETY & HOLD HARMLESS**

**APPROPRIATION**

Funds for this program must be appropriated for each fiscal year, and the Discover Nature School and MDC's obligations hereunder shall not be binding upon MDC for any period in which funds have not been appropriated.

**MDC CONSERVATION AREA VISITS**

Proper procedures must be followed to ensure the health of native ecosystems. Wildlife may only be captured using methods as directed and released unharmed at the point of capture following brief inspection. No wildlife may be removed from the area visited. If any plants will be collected, contact [Malissa.Briggler@mdc.mo.gov](mailto:Malissa.Briggler@mdc.mo.gov) to obtain a *Letter of Authorization for Plant Collecting*. When doing water studies, cleaning protocols are essential to avoid transfer of organisms or pathogens between water bodies and ensure aquatic ecosystems remain healthy.
